01. eMobility Innovation Awards 2026

The eMobility Innovation Awards are annual Awards aimed to recognize companies, organizations and professionals who have made markable contributions to the sustainable mobility field. These awards are designed to recognize industry-leading companies and organizations that are working towards a greener, cleaner and safer mobility future.

02. Organizer of the Awards

The eMobility Innovation Awards are organized and owned by **eMobility Expo World Congress - MOW 2026**. The evaluation and pre-selection process will be carried out in collaboration with a technical committee of international experts.

03. Who can participate

The eMobility Innovation Awards are aimed at companies, experts, researchers, professionals, entrepreneurs, universities, business schools, associations, and organizations from all over the world who want to present and discuss the latest **solutions and technologies** that are emerging in the new era of **sustainable mobility**, as well as to spread ideas and experiences that are being increasingly consolidated in the mobility sector.

All organizations which are identified with this aim are cordially invited to submit their proposals to the **eMobility Innovation Awards** Evaluation Experts Committee.

04. Categories

A. BEST MOBILITY COMPANY

The best mobility company award is intended to recognize the Company, who leads the Mobility sector by boosting mobility transformation through the development of new technologies, the implementation of new successful mobility programs or the promotion of sustainable mobility options.

B. BEST INNOVATIVE PROJECT FOR THE FUTURE OF MOBILITY

The Most Innovative Mobility Project or Research recognizes the most innovative and creative projects and/or research that have made a significant impact on the mobility field.

C. BEST PUBLIC SUSTAINABLE MOBILITY SOLUTION

This award is intended to recognize the best public mobility solution implemented in a city. New methods of transportation, new MaaS alternatives, solutions to improve mass transit and mobility hubs are some examples of projects or mobility solutions that potentially could apply.

D. BEST MOBILITY SOLUTION FOR CUSTOMER EXPERIENCE

This award recognizes the best mobility solution or technology which improves citizen service, their customer experience or develops social inclusion through mobility.

E. BEST PROJECT ORIENTED TOWARDS SUSTAINABLE MOBILITY

The award is intended to recognize individuals or organizations for their outstanding work in circular economy and sustainable mobility. This could include innovative technologies, policies, or practices that promote resource efficiency, waste reduction, and sustainable mobility.

F. BEST USE OF TECHNOLOGY TO IMPROVE MOBILITY

This award recognizes the best use of technology to improve mobility solutions. The use of AI, IoT, 5G, Blockchain, Data Technologies, Virtual or Augmented reality, Digital twins and any other disruptive technology.

05. Proposal Application

Proposals must be submitted electronically until **February 8th**. Only the submission through eMobility Expo World Congress - MOW website will be accepted. The submission implies the acceptance of the terms and conditions included in this online form, therefore the organization recommends the perusal of each item of the terms & conditions.

The proposal will consist of an abstract under 2.000 characters. **In addition to that, it will be required an executive summary under 500 characters** that explains the vision and objective of the project, a description of the innovation concerning the state of the art, and the positive impacts according to the mobility solution to which it is addressed. It will be positively valued the inclusion of the deployment plan carried out with a description of the necessary resources (talent-roles, skills-,teams) and the changes it represents for the companies, end users, and ecosystem in which the project is implemented.

The proposal may be complemented with attached files and photographs in a document under 5MB in either .doc, .docx or .pdf format. The form and all the complementary information provided must be in English (*proposals in other languages or formats will not be accepted*).

The organization may request any clarification or additional information on the proposals submitted. The awarded projects may be required to present their project in the congress program in its current edition or in the next.

06. EVALUATION CRITERIA

The proposals will be evaluated by the **eMobility Innovation Awards Evaluation International Experts Committee** according to criteria of innovation, disruption and leadership. The proposal will be structured so that it can be identified:

- The project vision and strategy
- The value proposition
- Project execution and deployment
- Innovative and disruptive nature of the project
- Environmental & Social impact

07. Evaluation Process

The evaluation process is divided in two phases:

PHASE 1:

Compliance with the regulations and pre-selection the organization and the International Experts Committee will carry out the first evaluation to check if the submitted proposal meets the defined selection requirements and criteria. The evaluation process will be carried out by the members of the Committee of Experts individually and will serve to choose the finalists for each category. Shortlisted candidates will be informed from **February 18th, 2026**. If needed and exceptionally, the organization will ask for complementary information to the candidate's proposal.

PHASE 2:

Winners' selection: the International Committee of Experts will meet the days prior to the celebration of the Delivery Gala, will evaluate the finalist projects, and will select the winner of each of the categories. Any prize award category could be declared void by the International Committee. The Committee may assign the nomination to a different category for which it was submitted. Be aware that International Committee of Experts decision is final and private and not subject to any queries or public investigations.

The winners will be announced during the **eMobility Innovation Awards Gala Dinner Ceremony** to be held on **March 11th, 2026** in a location to be selected by the Organiser.

08. Deadlines

Dates to keep in mind:

- 'Call for Awards' will be open until **February 8th 2026**, at 23:59:59 CET.
- Pre-selected Awards finalists candidates will be notified from **February 18th, 2026** onwards to the main email address specified in the registration form.

** The Steering Committee reserves the right to accept proposals before **18th February**.*

09. Prizes

eMobility Innovation Awards will give the winners with the following prizes:

- A double invitation to attend the awards gala dinner for each of the finalists in each category.
- Delivery of the award accrediting the award obtained and the corresponding category.
- Dissemination of each of the awards achieved to all the general and specialized media accredited at **eMobility Expo World Congress - MOW 2026**.

10. Intellectual & Industrial Property Rights

The participants are responsible for the authorship of the submitted proposal, he/she must be the owner of the intellectuality and, where appropriate, of the industrial rights. The participant agrees not to violate intellectual property rights, industrial property rights, copyright and/or image rights, and assumes the total responsibility of third parties: the organization is free of all responsibility.

If the proposal is a finalist, the participant authorizes the organization to disseminate, reproduce and publish their proposal in any type of format and by any means to publicize the **eMobility Innovation Awards 2026**.

11. Data Protection

Due to the confidential nature of the information provided, the organizers, the coordinator and the members of the Technical and Committee of the awards guarantee to maintain the identity of all participants and the content of their projects outside the sphere of the eMobility Innovation Awards 2026. This also includes all information about your current condition or development.

Once the project is selected as a finalist, the organizers of the awards will be able to make public all the details considered as public (name of the project, responsible organization, person in charge, web pages, description, purpose and category).
